

Living Waters Tabernacle Summer Camp

WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

I, _____ ("Participant"), wish to participate in the Living Waters Tabernacle Camp (the "Activity"), and as consideration for the right to participate in the Activity, I agree to the following:

1. I knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity, and do hereby release and forever discharge Living Waters aka Living Waters Tabernacle ("LWT"), located at 1701 South Sherman Street, Denver, Colorado 80210, its officers, directors, employees, affiliates, managers, members, agents, staff, counselors, teachers, volunteers, attorneys, successors and assigns (collectively, the "LWT Parties"), for any injury that I may suffer, which include but are not limited to physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, paralysis, economic or emotional loss, and/or death, as a result of traveling to/from and participating in the aforementioned Activity.
2. **I am voluntarily participating in the Activity and I understand that the aforementioned injuries and outcomes may arise from, but are not limited to my own or others' negligence, conditions related to travel, or the condition of the Activity's location(s). Nonetheless, I assume all related risks, both known and unknown to me, of my participation in this Activity.**
3. I understand that the Activity may be outdoors, often in direct sun with minimal shade, and around wooded areas. I understand there is a chance of coming into contact with hazards including but not limited to bears, mountain lions, wolves, coyotes, snakes, ticks, misquitoses, poison ivy/oak, and bees.
4. I acknowledge that this Activity may involve a test of person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, equipment, vehicular traffic and actions of others.
5. **I hereby release and fully discharge LWT and the LWT Parties from and against any and all claims or causes of action, including all liability for damage to personal property or personal injury which may result from participation in the Activity, whether caused by negligence or otherwise, to the fullest extent permitted by law.**
6. I further release, indemnify, and hold harmless LWT and their officers, directors, employees, volunteers, and agents from and against any and all claims, suits or actions of any kind for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and related costs. If LWT incurs any of these types of expenses, I agree to reimburse LWT.

7. I acknowledge that LWT is not responsible for errors, omissions, acts or failures to act of any party or entity, including, but not limited to the LWT Parties, conducting a specific event or activity on behalf of LWT.

8. **I UNDERSTAND AND AGREE TO ALL OF THE TERMS OF THIS WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT. I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS (INCLUDING MY RIGHT TO SUE) AND ACKNOWLEDGE THAT I AM WILLINGLY SIGNING THIS DOCUMENT. I HAVE ASKED AND RECEIVED ANSWERS TO ANY QUESTIONS I HAD CONCERNING THIS AGREEMENT'S MEANING AND EXECUTE IT FREELY, WITHOUT DURESS, AND IN COMPLETE UNDERSTANDING OF ITS LEGAL EFFECT AND OF THE FACT THAT IT MAY AFFECT MY LEGAL RIGHTS. MY SIGNATURE ON THIS DOCUMENT IS INTENDED TO BIND NOT ONLY MYSELF AND MY CHILD, BUT ALSO THE SUCCESSORS, HEIRS, REPRESENTATIVES, ADMINISTRATORS, AND ASSIGNS OF MYSELF AND MY CHILD.**
